2021 TAX LEVY ORDINANCE

ORDINANCE NO. 1605

COUNCIL BILL NO. 20-03

An Ordinance of the City of Corry, County of Erie, and Commonwealth of Pennsylvania, levying taxes and rents for the fiscal year beginning January 1, 2021.

WHEREAS, the assessed valuation of all land and buildings within the City of Corry, as determined by the Erie County Assessor's office on November 13, 2020, is \$212,325,242.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the City Council of the City of Corry, County of Erie, Pennsylvania:

Section 1: That a tax be and the same is hereby levied on all real, personal and mixed property within the said municipality subject to taxation for the fiscal year 2021 as follows:

Making for all purposes, the total sum of Ten and Thirty-Five one hundredths (10.35)mills on the dollar (\$1.035 on \$100.00) upon the last assessed valuation of the taxable property within the City of Corry.

Section 2: That also for the purpose of raising revenue for the City of Corry for the fiscal year beginning January 1, 2021, the following Ordinances shall continue in effect without re-enactment:

Ordinance No. 1088: A tax of one-percent (1%) of all salaries, wages, or similar compensation, and the net profits of business, earned by residents of the City of Corry or earned by non-residents within the City of Corry, under authority of Act No. 511 of the Commonwealth of Pennsylvania, approved December 31, 1965.

Ordinance No. 1056: Providing for the levy, assessment, and collection of Realty Transfer Tax for general revenue purposes under authority of Act No. 511 of the Commonwealth of Pennsylvania, approved December 31, 1965.

Ordinance No. 1458 as amended: Providing for the levy, assessment, and collection of an Annual Per Capita Tax for general revenue purposes under authority of Act No. 511 of the Commonwealth of Pennsylvania, approved December 31, 1965.

Ordinance No. 1480: Providing for the levy, assessment, and collection of a Local Services Tax for specific purposes under authority of Act No. 511 of the Commonwealth of Pennsylvania, approved December 31, 1965, as amended.

Section 3: Ordinance No. 833, as amended, shall be re-enacted in full, the receipts from which shall be used for sewer purposes only.

Section 4: Ordinance No. 1179, as amended, the Water Rate and Regulation Ordinance of the City of Corry, shall be re-enacted in full, the receipts from which shall be used for water purposes only.

Section 5: All Ordinances or parts of Ordinances in conflict herewith or supplied by the provisions hereof, be and the same are hereby repealed.

ORDAINED and ENACTED into law by the City Council of the City of Corry this 21st day of December, 2020, in lawful session regularly assembled.
